### RISK ASSESSMENT & EVALUATION

The Dutch Occupational Health and Safety legislation requires you to conduct a risk assessment and evaluation (RA&E). This means composing a list of all the possible risks on the working floor, as well as all the risk reduction measures you have taken and the risks for employees in special categories. The RA&E can further be specified with task risk assessments, safety studies, etc. An RA&E will, if so required, be evaluated by a certified expert, the so-called higher safety expert (SKO certified).



### **DEVELOPING SAFETY PLANS & PROCEDURES**

Your safety policies can be made by a systematic approach, or broken by the lack of one. Whether it concerns your plan of action following a

Risk Assessment & Evaluation, a company aid plan or a Safety & Health plan for the construction of a new installation.

### **CONDUCTING SAFETY INSPECTIONS**

Trust is a good thing, but inspections will always be necessary, also when it comes to your safety policies.

You are even required by law to conduct these inspections. A structured inspection by an independent and professional partner can be a good means of achieving this.
